

Submission Highlights HKU-GHK Institutional Review Board (HKU-GHK IRB)

1. Application Procedures

All applications, excluding industry-sponsored studies, shall be submitted by email to ghkirb@gleneagles.hk. Key documents for a submission should include but not limited to the following:

- i. Covering submission letter
- ii. Research application form
- iii. Ethical approval checklist
- iv. Protocol (with Version No. and Date)
- v. Information sheet and consent form (English & Chinese) (with Version No. and Date), if applicable (The IRB name in Chinese is 香港大學及港怡醫院研究倫理委員會) (Chinese documents should be prepared in Traditional Chinese)
- vi. Investigator's brochure, if applicable
- vii. CV of Principle Investigator (Signed and dated)
- viii. Other study-related documents, e.g. questionnaire, assessment tools, etc.
- ix. Certificate of insurance, if applicable
- x. Investigator's conflict of interest declaration form

Applications for industry-sponsored studies shall be submitted to the HKU Clinical Trials Centre (HKU-CTC).

2. Study Feasibility & Site Assessment

To ensure successful study implementation and multidisciplinary collaboration, the Research Office would vet the submission prior to listing for full-review, based on but not limited to the following, where applicable:

- i. Site feasibility (including study nature, available equipment and manpower, risks, etc.)
- ii. Logistic arrangement (including drug/laboratory processing, storage, shipment, etc.)
- iii. Staff training and awareness

Applicants may wish to consult the Research Office on the aforementioned prior to formal submission if need be. Please provide the protocol, investigator's brochure, drug/laboratory manual, and any documents that may deem necessary.

3. Fees & Charges

An initial review application fee of **HK\$25,000** will be charged for industry-sponsored studies.
